

WEEK ST MARY PARISH COUNCIL

The Parish Council Meeting took place on Monday 16th January 2012 at 7.30pm under the chairmanship of Mr L Davies with 8 Councillors and 0 members of the public present. The following matters were discussed:

Filled salt bin successfully purchased and placed on Green Hill opposite The Glebe

Housing Need Survey Cornwall Council Affordable Housing Team Leader is prepared to do a rural survey on housing need and identifying suitable areas of land, that will cost Parish nothing. Parish Councillors will walk round with him. It was agreed to go ahead as soon as possible. In addition Cornwall Council has issued a call for land for development

Application for toilets renovation grant has been made.

Playing Field : SWEB will repair broken door on electric meter this week.

Poor Man's Piece – a meeting with Cornwall Rural Community Council drew up possible options which the Trustees will now pursue with the Charity Commission.

Diamond Jubilee – any funds left over will be put towards Parish Hall renovation. As events are organised by Parish Council they will be covered by Public Liability Insurance.

Renewal/tenders for contracts (grass cutting, playing field grass, toilet cleaning) will be sought. In principle Parish Council prefers to award to someone in the village, within the context of best value.

Parish Greens – Jubilee committee is investigating a grant of 100 trees to include a Jubilee Oak. Mrs M Smith will look at costs of buying just the oak.

Highways – Either Clerk or Mr I Barriball will report faults to Highways direct.

Community Policing – New PCSO to start in April. Clerk to invite them to the Annual Open Meeting
