

WEEK ST MARY PARISH COUNCIL

An Extraordinary Parish Council Meeting took place on Monday 16th July 2012 at 7.30pm under the chairmanship of Mr L Davies with 9 Councillors, Cornwall Councillor Phil Tucker, and 0 members of the public present. The following matters were discussed:

NHS issues Phil Tucker will organise a Cluster meeting for local parishes on 24th September

Wind Turbines Bude Area Network Meeting on Monday October 8th 7pm at Parkhouse will discuss related planning issues, and the state of the roads. The public is encouraged to attend.

Register of interests must be updated and returned to Cornwall Council by 31st July

Replacement process for clerk post: Shortlisting, interview questions and contract will be drawn up by full Council on Friday 27th July. Interview panel will be on Monday 6th or Tuesday 7th August 2012.

Grant for office conversion and internet access: Grant awarded with extra money for broadband connection but this means a need to make a small charge for internet access to cover ongoing costs. Works will start September 2012.

Playing Field Planning permission for the playing field final condition has been discharged. Mr P Sachs has completed a Grant application for skateboard park; £100 donation from Diamond Jubilee also gratefully received and £45 raised at the Jubilee from the Treasure Hunt.. XTC, a company that builds multi-use games areas, also offers help locating funding and Mr P Sachs will pursue this possibility with them.

Parish Hall – Toute Ensemble will provide a medieval musical entertainment on Sunday 5th August 2.30-4.30pm

1. Glebe Court Week St Mary Holsworthy Cornwall EX22 6UP Conversion of old school building to dwelling (amended scheme to PA11/07079) - Mr D Short - **PA12/04371 (Case Officer - David Tapsell) APPROVED**

The following planning applications have been received:

1. 5B West Week Close Week St. Mary Holsworthy EX22 6XQ Conversion of garage to provide additional living accommodation. - Mr Antony Sachs - **PA12/05353 (Case Officer - R Baker)**. No comment.
2. Higher Whiteleigh Farm Whitstone Holsworthy EX22 6LB Extension to dwelling - Mr And Mrs Hepper - **PA12/05287 (Case Officer - R Baker)** Concern expressed about the size of the extension relative to the original dwelling, which is more than doubled by the proposal, and concern about what precedent this would set. Noted that the map is wrong and the road incorrectly shown.
3. The Barn Week Green Week St Mary Holsworthy Cornwall Removal of condition 2 (limiting occupation of the dwelling to a qualified local person) of planning application no. 2009/00210 dated 06.04.2009 - Miss Tracey Ward - PA12/05269 (Case Officer - Aimee Williams) Objection to the proposal, as the start on the property ladder for young local people must be preserved, development rules adhered to and the local condition should be maintained.
