

WEEK ST MARY PARISH COUNCIL

The Parish Council meeting took place on Thursday 9th January 2014 at 7.30pm under the chairmanship of Mr J Ward with 10 Councillors, the Clerk and Cornwall Cllr N Chopak present. No members of the public present. The following matters were discussed:

MATTERS ARISING –CC Corporate Legal Department has advised they are currently preparing a new training package, due late February, that focuses on interests and when to register them.

C CLLR N CHOPAK – C Cllr N Chopak advised that cuts to the mobile library service are under review.

PLANNING - 1 x Decision Notices approved by CC – PA12/0395017 - Submission of details to discharge condition 7 in respect of appeal decision APP/D0840/A/12/2180768 12.2013 PA13/10874 S52/S106 and discharge of condition apps. Trefrouse Week St Mary. Mr Peter Fusco. Condition discharged.
2 x planning applications - PA13/10056 - Outline application for an agricultural worker's dwelling. Land North West of Week Orchard Marhamchurch. Mr Trevor Congdon. The Parish Council agreed to request that the application is referred to the Planning Committee. PA13/10467 - Construction of an agricultural shed. Thatched Cottage Week Orchard. Mr Chris Congdon. The councillors agreed to inform to Planning Department that as the building is already up there seemed little point in making a response. Queries – C Cllr N Chopak is continuing to follow up matters previously raised. Planning issue re dwelling at Flooden Tor (out of parish). PA13/09955. The Clerk was directed to write to the Planning Department in support of the proposal.

CORRESPONDENCE – 7 items were placed for circulation and it was noted that a temporary road closure is planned Week Green to Highmoor 14 – 20 February for patching works.

WEEK ST MARY PLAYING FIELD – It was agreed to proceed with a grant application from CC Community Chest towards the cost of replacing the fence on the tennis courts.

WEEK ST MARY PARISH HALL - the water leak has been found and remedial action taken. It was agreed extra funding for the parish hall, at the current time, is contingent on other matters.

FINANCE - payments were approved. The bank reconciliation and balance sheets for the 3rd quarter were approved.

COUNCIL RESPONSIBILITIES

PARISH GREENS – the terms for the advertisement for tendering for grass cutting were agreed.

RESPONSE TO GOOD ENERGY RE COMMUNITY BENEFIT PRESENTATION - It was agreed to make a formal response to Good Energy on their presentation relating to community benefits and points in the response were agreed.

DATES FOR 2014 MEETINGS - It was agreed to continue to hold meetings on the second Thursday monthly.
