Minutes for the Annual Meeting Thursday 12th May 2016

All meetings are open to the press and public unless the Council decides otherwise

1. **Public question time** (15 minutes allowed for this)

Cllr Smith thanked all the public and Cllrs who attended the appeal.

5 members of the public attended regarding car vandalism opposite the pub – bringing it to the PC attention. Cars have been significantly 'keyed' on 5 separate occasions whilst parking on the stretch of road adjacent to the school house. Residents are trying to park elsewhere – as these events are most unexpected and disappointing. However, they are meeting with resistance when trying to find alternative spots. Whomever it was has now damaged all the cars of the residents of the triangle. The damage to the cars is substantial costing around £1000 to be repaired. These crimes have been reported to the police - PCC South has visited as one resident was in her house – 'they' tried to break into her house at the same time – she was terrified as she was home alone! It is criminal damage to vandalise a car; but as there isn't any cctv footage or witnesses, there is not a lot the Police can do. Farmers have knocked on doors previously – there are problems with larger agricultural vehicles getting past the parked cars. But emergency services vehicles can pass. Residents do not want this behaviour to continue and asked the PCs advice on how to prevent it

Residents do not want this behaviour to continue and asked the PCs advice on how to prevent it occurring again:

• Parking elsewhere

Cllr Chopak was emphatic in her assertion that the off road parking in the pull-in is open to everyone – it is not private - it's land owned by CC highways – first come first served for parking. It does not belong to the houses behind. The hedge behind also belongs to Highways. Their land doesn't start until the fence line. She investigated this matter fully last year. This information was published in previous minutes so the village should be fully aware of that. Parking on the road is legal. But the PC noted that every time a driveway is added the parking decreases on the road. PC has argued on each planning application that there is not enough parking with the houses but the planners are not taking any notice. There is quite a lot of parking in the Glebe – sure that your car wouldn't be vandalised; the residents might not be happy but would understand your need to prevent further worrying criminal acts. A resident noted that it is not just them that park in that area, visitors, overspill from the pub etc. The road past the pub is private – on the Canworthy Water road– don't park there. Cllr Chopak will investigate the possibility of removing a bank to create more parking.

All on street parking in the village is open to everyone providing they are not blocking people's driveways

Crime prevention

No other reported of keying in the village. It will be worthwhile advertising this issue in the press — Clerk to publish in the magazine — with further consideration for the local press if the behaviour continues. Residents could install flood lighting as a temporary measure and perhaps CCTV — pointing down towards the cars — a bit of the deterrent, but residents need to be careful about invading others' privacy. Cllr Pearce noted that trying to get in your house is far more serious issue.
