He has tried different ways to attract customers – provided food for 2 years – didn't work. Idea is now to turn it back into a residential house. **PA16/11045.** The Old Orchard Inn. Mr Jason Orchard. Change of use of public house (formerly the Green Inn) to a single dwelling. Identical to the plans that were previously submitted. No thought into the design at this point; solely change of use application. Cllr Hannaford noted that it was a shame that it is going – a loss to the village. Cllr Cluney noted that he would like a facility in the village for eating out. Parish Hall is available 2 nights a week. Cllr Ward noted that there is planning permission in the treetops development. Recognise the challenge of making a business work in a rural village.

It was **resolved** to express disappointment at the loss of a community facility but recognise the economic challenge of running a viable business in a rural setting.

# 4a. To receive County Councillor's report on Matter's Arising

Cllr Chopak reported that there is a current parking consultation – including Bude. Feedback from people who work in town would be useful – worthwhile going online to complete the survey. CC budget ratified council tax increase - 1.7% + 2% adult social care. Appeal hearing for the Bullers' Arms car park is scheduled for the 10<sup>th</sup> January at the Parkhouse centre. 3 days of public hearing has been allocated. Cllr Chopak asked all to note the Sustainable transformation plan. Quite significant changes to how hospital cover is provided. Cllr Smith noted that it was on the news that Stratton maybe facing closure. Cllr Chopak noted that it has a very active league of friends. Cllr Ward noted that it would be interesting to hear how many people go to either Holsworthy or Stratton from WSM. Holsworthy has quite a lot of clinics. Idea is to try to treat more people at home. Cllr Smith noted that Stratton provide A&E and folk do have a right to die in hospital. Poor access to health care is an historical problem in this area. Cllr Chopak noted that some of the services provided by Barnstaple are going to Exeter.
