# **Week St Mary Parish Council**

# Minutes - Thursday, March 7, 2024

- 1. Public question time (15 minutes allowed for this on matters on the agenda only) Three members of the public spoke about the anonymous letter that was recently received by the parish council. It was noted that the letter was sent to the football club out of courtesy, and to maintain the working relationship between the parish council and the football club. The parish council had no knowledge that the letter would be put on Facebook and it was disappointing to see it on there. Cllr Slade said the parish council recognises how the parish got the playing field, and it also recognises the hard work of all volunteers in the parish.

  One member of the public said, regarding the playing field path, that there was a lot of noise on Facebook about the path becoming a dog facility as well as human. He said this does not form part of a consultation. Chair, Carol Slade said no decision about dogs will be made at this stage, but consultation will be held further down the line.
- Cllr Chopak said Cornwall Council had confirmed a 4.99% council tax rise. Although she said Cornwall Council is better off than some councils, there are still savings to be met. Things under threat are school transport, libraries etc. The idea is being mooted that if rural parishes feed into bigger towns such as Bude and Launceston, residents should be contributing to the running costs of these things. The recycling and waste contract will be completed by April 2025. Some local parishes are beginning to get the wheelie bins and seagull proof sacks. The council leader will be coming to see everybody in May, in Bude. The forthcoming CAP meeting will have the main focus on health. Cllr Chopak also noted that the A39 overnight closure has been extended. Also, the Canworthy Water solar farm will be coming up at a Strategic meeting in June.

#### 4. Lambley Corner

Cllr Hamlyn has filled the ruts. He has asked Highways what they think would be acceptable to put on a corner. Cllr Hamlyn reported that a land search is being carried out. Checks are going to be carried to see if there was anything in the planning that would stop anything being put on the verge. If no problem, anything put there would have to be one metre back from the road. The parish council will be advised by Cornwall Council.

# 5. The Wyldes

Cllr Chopak said this time last year she was contacted regarding anti-social behaviour (increased traffic, people urinating in hedges) and an impact on the local community. She wanted to encourage communication between the organisers and the parish council. Two representatives from The Wyldes were in attendance. They clarified that Leopallooza will not be taking place this year, only The Wyldes, consisting of four weekends of shows in June and July. The 10,000 capacity has not changed. They said last year, the traffic met a school bus, so they will try to have a

chat with the bus services, and also more work will be put into parking (with a possible holding area for people who arrive early). Cllr Chopak said Week St Mary takes a lot of the impact, and asked for better signage to be put in place. The parish council will remain in contact with the organisers.
